Roles and Responsibilities:

As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes the following and the Antiragging Committee is majorly having responsibility to prevent the following: -

1. Any act that Prevents, Disrupts the Regular Academic Activity.
2. Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
3. Any unlawful assembly or conspiracy to ragging.
4. Any Act of Financial Extortion or Forceful Expenditure.
5. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
6. Any Act of abuse by spoken words, emails, SMS or public insult etc.
7. Any Act of Wrongful Confinement, committing unnatural offences, trespass or intimidation.

Responsibilities of Anti Ragging Squad

1. Anti-Ragging Squad will be working under the Monitoring of Anti Ragging Committee and will seek advice from the Anti-Ragging Committee.
2. The functions of Anti-Ragging Squad will be to keep a vigil and stop the incidences of Ragging, if any, happening / reported in the places of Student aggregation including, Classrooms, Canteens, Buses, Grounds, Hostels etc.
3. The Squad will also educate the students at large by adopting various means about the menace of Ragging and related Punishments there to.
4. A gamut of positive reinforcement activities are adopted by Anti-Ragging Squad for orienting students and molding their personality for a better cause.
5. They shall work in Consonance and Guidance of Anti Ragging Committee.

Duties of the Anti-Ragging Squad

1. To be vigilant at all hours including at odd hours all around the Campus and other places vulnerable to incidents of, and having the potential of, ragging and shall be empowered to inspect such places.
2. Conduct anonymous random surveys among freshers to check whether the Campus is indeed free from ragging.
3. To ensure the display of posters/tabs on Main and Departmental Notice Boards and other places such as canteen, Library, Sports Lounge, Gymnasium, Bus stops and other prominent designated places.
4. Also, to monitor the welfare of fresh students outside the campus.
5. Any other activity the Anti Ragging Committee might delegate to the Squad.

Standard Operating Procedure (SOP)

MONITORING OF ANTI RAGGING

- ❖ Anti ragging committee is constituted by nominating faculty from each department and a Whatsapp group is created by the convener for effective communication with members.
- ❖ Vulnerable points for ragging are identified like hostel, canteen, etc.
- ❖ Rooms allocated to new entrants in the hostel are identified and special care is taken about them.
- ❖ A time table of supervision for different locations is made containing time slots and faculty assigned for them. This arrangement is circulated to all the faculty members involved in monitoring anti ragging.
- ❖ Regular meetings are conducted to take stock of monitoring.
- ❖ The visited staff members will update the registers kept at points like hostels and convener.
- ❖ Boards displaying names of authorities to be contacted with phone numbers are put up at prominent places.
- ❖ Undertakings are collected from all students and their parents stating that they/their ward do not indulge in ragging.
- ❖ Boards containing information on severe consequences of ragging are displayed at class rooms, labs, canteens etc.
- ❖ Compliance of anti-ragging procedures are followed is updated in MHRD web site.
- ❖ Students are cautioned periodically to stay away from the menace of ragging.
