On behalf of KTH Royal Institute of Technology, Stockholm, we are pleased to welcome you to the Engineering Design Masters programme, **Machine Design Track**, starting in August 2021 and concluding in June 2023.

Please note the programme is taught in English, and is **full-time** for 2 years: three terms of lectures, coursework and project work, plus one term devoted solely to your Master Thesis project. Upon completion of the programme you will be awarded the Swedish degree "Teknologie masterexamen", which translates into English as "Degree of Master of Science" (120 credits).

If you decide not to take up your place this autumn, please contact us at <u>engineeringdesign@kth.se</u> well in advance so that we can offer it to someone on the waiting list. (You should also decline your place on University Admissions.)

Mandatory Programme Registration

At **8am on Monday 30 August** we will hold a short introduction to Engineering Design and register you for the programme (**please bring your passport**). This will take place at the KTH Department of Machine Design, Brinellvägen 85. There will also be Track-specific information sessions where you will meet your Track Leader and fellow Track students. And on Wednesday 1 September, there will be an all-day kick-off competition and a chance to get to know everyone.

We will email you on Monday 23 August with more details, and a copy of the schedule for the compulsory courses for the first couple of weeks.

You need to be here at KTH ready to start classes on Monday 30 August. If you have any problems with this date please contact us at <u>engineeringdesign@kth.se</u>. We realise that sometimes visa issues do cause delays, and that with the current COVID-19 situation (see next page), more issues may arise than normal. If necessary, KTH will – *by arrangement* - allow you to register up until 3 September. All students are encouraged to plan to arrive on one of the KTH Arrival Days (see next page).

KTH Introduction Activities and Preparation for Arrival

You should already have received an electronic newsletter from the KTH Admissions and International Students Office, telling you about key dates and what to do next – e.g. insurance, when to apply for accommodation, dates for payment of fees, pre-programme introduction activities etc. KTH encourages new students to participate in the pre-term introduction activities which include both informative and social events.
