

- To identify steps to be taken for quality benchmarks/ parameters for various academic and administrative activities of the institution for quality improvement
- To create a learner centric environment for imparting quality education and to provide the required knowledge, skill and technology for participating in the teaching and learning process
- To develop curriculum to serve the industry needs, analyze the feedback from students, employers and other stakeholders on quality related institutional processes
- To arrange self evaluation, to collect observations by the department heads on quality annual performance related issues by setting the goals for faculty
- To propagate the information on various quality parameters of higher education
- To organize inter- and intra-institutional workshops, seminars, conferences on quality related themes and promotion of quality circles
- To organize orientation, refresher, thematic, short term, and long term programs to promote quality among staff members
- To organize seminars on ethics, integrity and values for staff and students
- To be the nodal agency of the institution for coordinating quality related activities including adoption, adaption and dissemination of best practices
- To develop quality culture in the institution
- To conduct workshops/ lectures on new developments/Policy changes/ guidelines etc. at the central/ state governments/ MHRD/ UGC/ AICTE/ VTU and other academic and regulatory bodies
- To prepare the Annual Quality Assurance Report (AQAR) as per guidelines and parameters of NAAC for submission to NAAC.
