Roles and Responsibilities

- Convener of the committee shall convey a meeting of the members and discuss the complaint received from the Principal.
- 3. The Committee shall organize the 'Code of Conduct for students' awareness program.
- The Committee may call the candidate to seek an explanation and hear him/her. The explanation shall be taken in writing.
- After hearing all the above persons, they shall report their findings in writing, along with punitive action (if any malpractice was detected) to the Principal according to the college guidelines and norms.
- Conduct periodical meetings every quarter and send the minutes of meetings to the Principal and IQAC for filing the records.
- Under disciplinary action, the principal is empowered to fine, suspend or even expel a student from the college in the interests of the institution.
- Late coming / early leaving without permission will constitute indiscipline and attract punishment.
- 9. Wearing a formal dress and ID card is compulsory. Wear the apron where ever necessary in labs. Without this, entry into the campus can be denied. Repeated violations will result in the suspension of the student from the Department.
- 10. Students are not permitted to possess or use mobile phones on the academic premises.
- Browsing is not allowed during lab hours. Students are not allowed to misuse the internet facilities.
- 12. No one will be allowed to listen to music from any device inside the college campus.
- Every Student shall conduct himself/herself in such a way to cause no disturbance to the working of the classes or fellow students.
- 14. Consuming alcohol and smoking is strictly prohibited in the hostel and college campus.

- 15. No function shall be arranged by the students in the hostel or college campus without prior permission from the respective hods and principal.
- Writing on desks, walls, pillars, bathrooms, and furniture or blackboards, etc. is strictly prohibited.
- Eating snacks / taking lunch inside the classrooms, labs, or along corridors are not permitted.
- The cost of any damage, if caused to college property will be charged to the accounts of the students responsible for the damage in addition to disciplinary action.
- 19. Students are advised to switch off fans and lights when they leave the classrooms/labs.
- 20. Furniture in the classrooms should not be moved or displaced.
- No one will be allowed to whistle, shout or sing aloud, throws papers, or other articles inside the classrooms/campus.
- 22. No student shall remain in the hostel during class hours unless he/she is sick and is permitted to be on leave.
- 23. In the event of continued poor performance in internal tests and poor class attendance by any student, remedial action taken by the college should be followed.
- It is the responsibility of all to maintain cleanliness and order in the lecture rooms and at other premises.
- Any kind of violations and disciplinary actions taken there will be communicated to the parents/guardian/warden.
- Motorcycle rider and backseater must wear helmet & triple riding of motorcycle and driving of car without a seat belt is prohibited.
- 27. Students may be accountable for their acts which constitute violations of code.
- 28. The Disciplinary Committee reserves the right to take necessary and appropriate action to protect the safety and wellbeing of the campus community. Final authority in disciplinary matters, however, is vested in the college administration and the management.




